1.0 Approval of list of Candidates / NOMCOM

Alan Barrett reported that he sent two email messages to the NomCom after the last meeting of the Board. The first message was to request NOMCOM to provide to the Board the full list of candidates including the details as per Bylaws section 12.14(i). The second message was to request the NomCom to consider increasing the candidate slate. He gave NOMCOM the assurance that the Board will not interfere with the NomCom's responsibility to finalize the slate in terms of Bylaws section 9(ii)(d).

The CEO reported that the Board mailing list had originally been configured to block email from non-Board members. It has now been made open. The staff liaison to the NomCom, Ernest, has sent the full list of nominations to the CEO with the request that he forward it to

the Board. Ernest did not consider sending it directly to the Board because he thought the Board list was still closed.

The CEO did not notice the email in time, and forwarded it to the Board only after the set deadline. The CEO apologized and informed the Board that the NomCom did not miss the deadline.
