### **Comprised of 9 Directors:**

6 – Regional	2- Non-regional	1- CEO
Elected at the AGMM to:	Elected at the AGMM to: Seat 7	Board appointed: Seat 9
Seat 1: Northern Africa Seat 2: Western Africa Seat 3: Indian Ocean Seat 4: Central Africa Seat 5: Southern Africa Seat 6: Eastern Africa	Seat 8	





#### Term of Office

- Directors hold office for 3-year terms.
- Term expires on 3<sup>rd</sup> AGMM after appointment
- Upon expiry of term, Director is eligible for reelection.





#### **Election Process**

#### Election of Directors is sequential, as follows:

Seats 1, 2,7: Northern,





- Seats 3, 4, 8: Indian Ocean Central & non-geo
- Seats 5, 6: Southern and Eastern Africa.





#### NomCom

- Duties:
- Ensure a satisfactory number of individuals via for open positions
- Supervise the conduct of the polls
- Prescribe qualification criteria and interview candidates




